**YOUR CHILD IS DUE: DOSE 2 COVID-19 VACCINATION**

As many of you will be aware via national and local news a second dose of the Pfizer vaccine is now recommended for all children aged 12 to 15 years.

Following the recommendation, parents/carers can choose for their child to receive this important second vaccination either in school or at a community clinic. If you have already booked an appointment at a community clinic and are able to attend, please keep the appointment that you have already booked and you do not need to complete the Consent Form. However, if you would like your child to be vaccinated in school the School-aged immunisation team will be visiting all secondary schools across Oxfordshire in the Spring term to offer all students in years 8-11 the second dose of the covid-19 vaccine. **No vaccines will be administered without valid consent.**

If you choose for your child to receive their second vaccination in school, you will need to submit another Consent Form which you can access via the link below. **If your child has not received their first dose this form can also be completed to provide Consent for a First Dose. Any previous forms submitted for Dose 1 cannot be used.**

If you choose for your child to receive their second vaccination in school, you will need to submit another Consent Form which you can access via the link below.

**Please note that due to the impact of the Omicron variant on staffing levels we will not be able to guarantee to immunise all consented children on the date above and priority will be given to children with additional needs. If you have submitted a consent form and we are unable to vaccinate your child, you will be notified by email. If your child is not vaccinated please book an appointment through the [National Booking Service](#).**

If your child tests positive for Covid-19 or the vaccination is given in another location following submission of the Consent Form please send in a letter on the day of vaccination for the attention of the Immunisation Team.
