FSA 200 Club Lottery Rules & Application to Join

The FSA 200 Club has been set up to raise money for Fitzharrys School, particularly for larger projects which would benefit the greatest number of students. The Club will be run by the FSA Committee.

The initial target is to sell 200 shares. Anyone over the age of 16 can buy shares in the FSA 200 Club. Each share will be sold at £5.00 per month, payable by Standing Order for an initial minimum period of 12 months*. Fees will be taken from your bank account on the 1st of every month and the draw will take place once we receive the bank statement for that month. You will be entered into a draw every month to win a cash prize. Application to join the FSA 200 Club is possible at any time during the year.

The size of the monthly prize money will depend on the number of shares sold, but if all 200 shares are sold, there will be 3 prizes each month of £250, £100 & £50. This is 40% of the monthly income. 55% of the income will go to school and 5% assigned to administration costs. *The prizes will be reduced proportionately while the number of members of the 200 Club is less than 200. With less than 100 players, the prize money will be split into 1st prize and 2nd prize only, but this will still equate to 40% of the monthly income.*

Only the numbers for the shares that have been sold will be entered in the prize draw. Share certificates will be issued to all shareholders and the numbers checked against our bank statement before each draw is made.

Please complete the attached Application Form/Standing Order mandate and send it to school in an envelope marked "FSA 200 CLUB - Stacey Holt".
